The 29 application period shall take place during the Fall semester upon being called by a twothirds (2/3) vote of the SGC-MMC Senate. 30 31 32 Section IV: Enforcement 33 This Bill shall be presented to the Student Body, the Office of the Vice President of Student 34 Affairs, and all relevant committees on behalf of the Student Body by the SGA; 35 36 Section V: Enactment 37 This Bill and all its contents shall be the official law of the SGC-MMC upon passage by the SGC-MMC Senate and approval of the SGC-MMC Student Body President; 38 39 40 **Section VI: Implementation** Upon the enactment of this council bill, this shall be the official law of the SGC-MMC and shall 41 42 make any prior legislation that conflicts with this legislation hereby null and void; Upon the passage and approval of this council bill, the contents of the it shall be made 43 incorporated into the SGC-MMC Statutes and those provisions of the SGC-MMC Statutes which 44 45 contradict this council bill shall be made null and void. 46

SB1813 – A BILL TO AMEND THE PROCEDURES FOR FILLING SENATE VACANCIES

PER SGC-MMC STATUTES, ARTICLE IX. AMENDMENTS AND PROCEDURES, SECTION 9.02 PROCEDURES (b) (ii)

"Once the legislation has been delivered to the President, they shall have five (5) business days to sign or veto legislation per Article III of the SGA Constitution."
