Executive Order 02-02

By the authority vested in me as President by the Constitution and the Statutes of the Student Body at Florida International University, it is hereby ordered as follows:

- WHEREAS;** Student Spaces are critically important to the success of the student body in their academic careers
- WHEREAS;** The Game Room in the Graham Center has not seen substantial renovations
- WHEREAS;** COVID-19 has resulted in larger fund balances in the Accumulated Cash Balance Account
- WHEREAS;** These funds should be expended for the benefit of the student body
- WHEREAS;** The Executive Board has approved this expenditure

NOW, THEREFORE, I, Alexander A. Rubido, Student Body President of Florida International University, in obedience to my solemn duty to uphold the Constitution and Statutes of Student Government and pursuant to SGAC§5.03.1.9 and SGAS§4001.4 issue the following order;

Section 1. Six hundred and sixty thousand dollars (\$660,000) are hereby ordered to be expended immediately for the execution and implementation of the Graham Center Game Room renovation

Section 2. The Release of the funds to the Graham Center for this purpose is contingent upon continued meeting with the Student Body President regarding status of the project and SGA consent to final planning and designs
