

## **Executive Order 05-05:**

By the authority vested in me as President by the Constitution and the Statutes of the Student Body at Florida International University, it is hereby ordered as follows:

WHEREAS, SGAS§4002.4.1 states that the Student Body President may create and appoint of new executive branch departments, committees, or task forces.

WHEREAS, during the budget deliberations, some concerns were raised regarding the policies and practices of the Center for Fraternity and Sorority Enrichment.

**NOW, THEREFORE,** I, *Francesca Casanova*, Student Body President of Florida International University, in my obedience to my solemn duty to uphold the Constitution and Statues of Student Government and pursuant to SGAS §4002.4, issue the following order to create the **Student Government Association Department of Greek Enrichment and Expansion:** 

# STUDENT GOVERNMENT ASSOCIATION DEPARTMENT OF GREEK ENRICHMENT AND EXPANSION

### Mission

The mission of the SGA Department of Greek Enrichment and Expansion is to empower the student voice and prioritize the student experience in fraternity and sorority life.

## Purpose

The SGA Department of Greek Enrichment and Expansion will convene to reform the policies and practices utilized by the Center for Fraternity and Sorority Enrichment.

## 1000 Time of Dissolution

The SGA Department of Greek Enrichment and Expansion was formed with the purpose of proposing policy reforms for the Center for Fraternity and Sorority Enrichment to adopt by the beginning of the Fall 2025 semester. The SGA Department of Greek Enrichment and Expansion will dissolve automatically after the Chairman has delivered the department's report and recommendation to the Student Body President.

#### 2000 Composition

The Department of Greek Enrichment and Expansion shall be comprised of (5) members; all members shall be selected by the Student Body President, with two members to be selected as Chairman and Vice-Chairman.

#### 3000 Chairman, Vice-Chairman, and Member responsibilities

- 3001 The Chairman shall serve as chair over all department meetings; draft meeting agendas; represent the department in all matters; and sign and deliver the department's report and recommendation to the Student Body President.
- 3002 The Vice-Chairman shall serve as chair in the absence of the Chairman and sign the department's report and recommendation to the Student Body President.
- 3003 All members of the department shall sign the department's report and recommendation to the Student Body President

#### 4000 Report and Recommendation

- 4001 The Department shall convene as necessary to review the policies and practices of the Center for Fraternity and Sorority Enrichment. The Department shall recommend policy reforms that better reflect the student voice and prioritize the student experience that students want.
- 4002 The Department shall invite student feedback regarding the policies and practices of the Center for Fraternity and Sorority Enrichment.
- 4003 The Department shall discuss Center for Fraternity and Sorority Enrichment policies and practices.
- 4004 The Department shall approve a final report and recommendation which will include:
- 4004.1 A statement on behalf of the SGA Department of Greek Enrichment and Expansion.

- 4004.2 A report, which provides the student feedback received regarding the policies and practices of the Center for Fraternity and Sorority Enrichment.
- 4004.3 Recommendations, to be implemented by the beginning of the Fall 2025 semester.

**NOW, THEREFORE,** I, *Francesca Casanova*, Student Body President of Florida International University, in my obedience to my solemn duty to uphold the Constitution and Statues of Student Government and pursuant to SGAS §4002.4, issue the following order to appoint the following students to comprise the **Student Government Association Department of Greek Enrichment and Expansion**
