IV. New Business

A. Reading of Legislation SR 03 003: The Keep Dreaming Act

1. Senator Moya-Palacios read The Keep Dreaming Act
2. Chairman Cicconi motioned to go into a 5-minute question and answer period
3. Vice-Chairman Campbell seconded the motion
4. Vice-Chairman Campbell asked Senator Moya-Palacios to clarify the statement, "Recipients don't know any other country than the United States".
5. Senator Moya-Palacios explained that these children came to the US between ages 3-6 and are not accustomed to any other country than the United States
6. Senator Cicconi asked what the dots on the resolution stand for
7. Senator Moya-Palacios explained that there is more information that isn't included and that is what the dots stand for
8. Chairman Cicconi declared that the resolution is unfinished therefore it cannot be passed
9. Vice-Chairman Campbell expressed agreeing remarks

10. Senator Moya-Palacios expressed that the dots were there because the Senate President advised him to do so
 11. Senator Moya-Palacios proceeded to edit the document
 12. Chairman Cicconi asked Senator Moya-Palacios to clarify the statement of in-state tuition waivers being given to DACA recipients by FIU
 13. Senator Moya Palacios explained that DACA recipients are given waivers that allow them to pay in-state tuition
 14. Senator Moya Palacios also explained that the DACA status allows recipients to work and have a driver's license
 15. Chairman Cicconi suggested that this clause could be more specific by stating these rules are for Floridians
 16. Vice-Chairman Campbell ordered to extend the discussion period by 5 more minutes
 17. Vice-Chairman Campbell asked why it was necessary to show what FSU SGA did for DACA students in the legislation
 18. Senator Moya-Palacios explained that this clause symbolizes what other institutions are doing for DACA recipients
 19. Vice-Chairman Campbell asked how many DACA recipients are at FIU
 20. Senator Moya-Palacios explained that he does not know the answer to that question but he is willing to get statistics from admissions
 21. Senator Cicconi expresses his distaste for the clause pertaining to how FSU treats their DACA students
 22. Senate Pro Temp Stangl explains that he is unsure if the university can say how many DACA students are at FIU
 23. Chairman Cicconi edited the FSU-related clause
 24. Chairman Cicconi noticed that the Senate President had provided numerous changes and recommendations for the legislation that Senator Moya-Palacios didn't notice
 25. Vice-Chairman Campbell suggested that Senator Moya-Palacios come back next week with polished legislation that can undergo voting
 26. Chairman Cicconi deleted the FSU clause
