Pharmaboxes Near Residence Halls

At-Large Senator Ashley Nuñez, Engineering and Computing Senator Cristhofer Lugo, and Housing Senator Alexander Sutton introduced the following Resolution which was presented on the Senate Floor

# **A Resolution**

To support the installation of Pharma Boxes near the residence halls so that on-campus students have access to them 24 hours a day, 7 days a week.

**Whereas,** Pharmabox is a business that has developed the first automated retail system for overthe-counter (OTC) and personal care pharmaceutical products;

**Whereas,** Pharmaboxes can be accessible 24 hours a day, 7 days a week, and offer a state-oftheart system that provides the customer with immediate top-quality products based on necessities and healthcare;

**Whereas,** there are about 3,300 FIU students who live in the residence halls at the Modesto A. Maidique Campus (MMC);

Whereas, there are FIU students living in the residence halls on campus who do not have access to transportation that would allow them to visit pharmacies to obtain the products they may need;

**Whereas,** there are currently two Pharmaboxes located on the Modesto A. Maidique Campus (MMC) in the Graham Center and the Green Library;

**Whereas,** the two available Pharmaboxes that students can access are located in buildings that having closing times and are not open 24 hours a day, 7 days a week;

**Whereas,** the two available Pharmaboxes that students can access are located in buildings that may be over 2000 feet away from their residence halls;

**Whereas,** FIU on-campus residents may feel uncomfortable or unsafe walking in the evening to the two locations where the Pharmaboxes are located due to limited lighting;

**Whereas,** in a survey conducted among the on-campus residents at FIU MMC, 93.7% of respondents said they know what a Pharmabox is;

**Whereas,** in a survey conducted among the on-campus residents at FIU MMC, 54.4% of respondents said they have used the Pharmaboxes on campus;

**Whereas,** in a survey conducted among the on-campus residents at FIU MMC, 86.1% of respondents said they were aware the only two Pharmaboxes in the Modesto A. Maidique Campus (MMC) were located in the Graham Center and Green Library;

**Whereas,** in a survey conducted among the on-campus residents at FIU MMC, 91.1% of respondents said they would like to see a Pharmabox near housing that is accessible 24/7:

**Whereas,** University Towers may serve as a location for the installation of the first Pharmabox near residence halls, due to the 24/7 access available to this building;

**Now Therefore,** the Senate of the Student Body Resolves that Florida International University take action to install more Pharmaboxes near residence halls at the Modesto A. Maidique Campus to serve the needs and ensure the safety of FIU students.
