Whereas, Shellhacks is an event hosted by UPE; it is Florida's largest hackathon; it is open to all students with the interest of coming to learn the latest technologies, build innovative projects, and showcase their talents regardless of majors;

Whereas, Shellhacks brings major sponsorship to Florida International University such as but not limited to Google, Microsoft, and Nike;

Whereas, Shellhacks will be held virtually this year due to pandemic;

Whereas, among the many expenses Shell Hacks will be paying for this year, Shell Hacks will be providing 1,100 shirts to all students in attendance at the event, which will "market FIU and Shell Hacks," and which will cost a total of \$6,875.00, of which SGA will be covering \$2,500.00;

Whereas, the shirts will feature the logos of all sponsors of Shell Hacks on the back of the shirt, including the SGA logo, because of the fact that SGA is a sponsor of Shell Hacks insofar as it is assisting in paying for these shirts;

Now Therefore, The Senate of the Student Body does resolve to expend \$2,500.00 from the Legislative Line Item of the Student Government Organization to Upsilon Pi Epsilon for the purpose of shirts at the Shell Hacks event, as mentioned above.
