A BILL

To appropriate \$2,580.30 for the purpose of providing tables, chairs, tents, catering, giveaways, and marketing for the annual Sustainability Fair, held on April 5th, 2023.

Whereas, FIU is located in South Florida, one of the nation's areas most susceptible to environmental issues, including but not limited to: water quality, sea level rise, habitat loss, and plastic waste;

Whereas, in order to achieve higher environmental stewardship at the university level, it is essential that we take the necessary steps to transmit our sustainability efforts to our students, faculty, and community in an engaging manner;

Whereas, the Office of University Sustainability as well as the many sustainability- focused student organizations such as the Green Campus Initiative and the Society of Sustainable Souls, host an annual Sustainability Fair for the aforementioned purpose;

Whereas, the Sustainability Fair is intended to promote sustainability by creating a collaborative environment in which the FIU community can learn about and participate in environmentally-friendly practices;

Whereas, the Fair will be held on April 5th, 2023 at GC Lawns from 10 am-2 pm;

Whereas, SGA has requested GC Lawns Hill, West, and Triangle along with tables, chairs, and tents for a total of \$1,224.00

Whereas, SGA intends to further giveaway the sustainable items available at the Student Government Association MMC office such as tumblers, reusable utensils, tote bags, etc. to attract students during the tabling events;

Whereas, we estimate 400 students at the Sustainability Fair;

Whereas, SGA intends to purchase catering from Chartwells for the Sustainability Fair to provide food priced at \$1,256.30;

Whereas, SGA intends to host the appearance of Florida International University mascot, Roary, from 12 pm -1 pm at a price of \$100.00.

Now Therefore, the Senate of the Student Body resolves to expend \$2,580.30 from the Legislative Branch Line Item of the Student Government Association for the purpose of providing catering, giveaways, and marketing for the annual Sustainability Fair, held on April 5th, 2023.
