**Whereas**, in order to maintain the Halloween spirit, candy and candy bags will need to be purchased and will cost \$150.00,



**Whereas**, in order to promote the event flyers and stickers and any other promotional will also be purchased at a cost of \$125.00,




**Presidential Signature of a Senate Bill**


