Meet Your Dean Fall 2023

IN THE SENATE

September 1, 2023

Engineering Senator Hua Hui Vogel and Senate President Pro-Tempore Tiara Campbell introduced the following bill, which was presented on the Senate floor:

A BILL

To appropriate \$2,859.31 for the purpose of Meet Your Dean.

Be it enacted by the Senate of the Student Body at Florida International University assembled,

Whereas, Meet Your Dean is a semesterly event held at FIU, hosted through the Student Government Association (codified by S.B. 03 008);

Whereas, Meet Your Dean is designated to facilitate access to each student's designated Dean or administrative representative;

Whereas, The Meet Your Dean event will be held Thursday, November 16th, 2023 within the Tamiami Multipurpose Room from 6 PM - 8 PM;

Whereas, The Student Government Association will be utilizing the Tamiami Multipurpose Room and intends to spend \$200 on the room rental;

Whereas, The Student Government Association intends to supply dinner for the Meet Your Dean event with the purchase of food, priced at \$2,121.60, and drinks, priced at \$128.93;



Whereas, The Student Government Association intends to have two attendants for the Meet Your Dean event to serve and replenish the food, priced at \$258.78;

Whereas, The Student Government Association intends to supply Eco-friendly dinnerware for the Meet Your Dean event with the purchase of service items, priced at \$150;

Now Therefore, the Senate of the Student Body resolves to expend \$2,859.31 from the Legislative Branch Line Item of the Student Government Association for the purpose of providing dinner for the Meet Your Dean event.
