A BILL

To establish the Disabled Student Union (DSU) as a Bureau of the Student Government Association.

Be it enacted by the Senate of the Student Body at Florida International University assembled,

Whereas, According to SGA Constitution §9.01.3 "Bureaus shall be student organizations whom have their creation, purpose, structure, and constitution approved by the Student Government Association. Bureaus shall be the student organizations created for the express purpose of serving specific areas of student concern such as race, religion, ethnicity, sexual orientation, culture, affinity, social group, or other purpose as approved by the Student Government Association for the University Community as a whole."

Whereas, The Disabled Student Union is a Student Organization that serves Disabled students and the Student Body as a whole for the specific purpose of providing education, awareness, and advocacy through events and initiatives to promote inclusivity and accessibility while fostering an affirming community for all.

Whereas, The Disabled Student Union is a Student Organization that serves the Student Body as a whole with the mission statement to provide a safe, accessible, and inclusive space for all students by empowering students to advocate for Disability justice, educate others about barriers of inaccessibility, build relationships with administration, establish a strong FIU community through impactful intersectional programming, and create connections in South Florida, and the greater community.

Whereas, The Disabled Student Union has submitted all documents necessary and proper for their formation as a Bureau in the Student Government Association.

Whereas, The Disabled Student Union registered under the Registered Student Organization Council (RSOC), in July 2023, with tremendous traction by the Student Body.

Whereas, The Student Government Association and the Student Body as a whole gain an extreme benefit from this organization and its continued existence.

Whereas, The Disabled Student Union has submitted documentation detailing their intent to join the Student Government Association as a Bureau.

Whereas, The Disabled Student Union has over 80 active members in the organization.

Now Therefore, the Senate of the Student Body does hereby recognize the Disabled Student Union (DSU) as a unit of the Student Government Association and does hereby confer the status of Bureau to the Disabled Student Union from this point forward.

Now Therefore, the Senate of the Student Body encourages the Budget Committee allocate money to the Disabled Student Union for the 2024-2025 fiscal year to ensure the solidification of being an SGA Bureau on campus.
