introduced the following bill, which was presented on the Senate floor

A BILL

To appropriate \$4,600.00 for the purpose of Nicole Wertheim College of Nursing and Health Sciences Spring 2024 Pinning Ceremony.

Be it enacted by the Senate of the Student Body at Florida International University assembled,

Whereas, The Nicole Wertheim College of Nursing and Health Sciences Dean's office hosts a pinning ceremony for every graduating class of nursing students.

Whereas, The Spring 2024 cohort is comprised of 154 students and is having their ceremony on April 27th.

Whereas, this event is to celebrate the accomplishments of the students throughout their 2 years of nursing school. It is the most important milestone in the undergraduate's nurse's career celebrating becoming a Registered Nurse.

Whereas, last year the Student Government Association has allocated funds for this ceremony.

Whereas, the college has already raised \$2,000 and is looking at other ways of fundraising for the event.

Whereas, the funds allocated would be used to pay Ramax productions a company that has been used for this ceremony in the past.



Whereas, the original total was \$10,360.00 but because of a loyalty rewards and discounts has discounted the price by \$5,716.02.

Whereas, The sound system with ambience music is \$495, 20 wireless LED lights is \$800, 2 86" TV monitors \$660, 30' blue velour drapes \$798.98, 24 wireless LED lights \$600, delivery set up and breakdown \$1,290.00, the total costing \$4,643.98.

Now Therefore, the Senate of the Student Body resolves to expend \$4,600.00 from the Legislative Branch Line Item of the Student Government Association for the purpose of covering part of the expenses as listed above for the nursing pinning ceremony.
