Archive Act

9 Section I: Policy

10 The proposal outlined in this Council Bill are in compliance with the authority granted in Article
11 III, Section 5.A of the Student Government Association Constitution;

12 This proposal amends the SGC-MMC Statutes starting with Article III, Section 3.04, Subsection
13 (d), Sub-subsection (i), Paragraph (7)

15 Section II: Terms

16 The following terms are defined as to ensure the legality of this bill:

17 A. "SGA" will hereby refer to the Student Government Association at Florida International
18 University;

19 B. "SGC-MMC" refers to the Student Government Council of the Modesto A. Maidique
20 Campus;

22 Section III: Bill

23 THEREFORE, LET IT BE ENACTED THAT SECTION 3.04 OF ARTICLE III OF THE MMC
24 STATUES BE AMENDED AS FOLLOWS:

25 Article IX. Amendments and Procedures

26 Section 3.04 Senate Committees

27 (d) Rules, Legislation and Judiciary Committee

28 (i) Purpose and Responsibilities

- 29 (7) It is the responsibility of the Rules Committee to maintain a register of
30 all statutes amendments passed by the Senate and made effective by
31 the SGC-MMC President.
- 32 a) The register shall be maintained as a separate print and digital
33 document accessible to all SGA officials and the public.
- 34 b) The document shall be updated and made public within one (1)
35 week of an amendment becoming effective.
- 36 c) The register will be separated by Article in numerical order,
37 with each article maintained as its own section.
- 38 d) Each entry in the register shall be codified as follows:
- 39 i) Commence with a square bracket ([), followed by the
40 numerical Senate Session number (#) and an m-dash
41 (—), followed by Agenda Item number of the
42 amendment (SB##), followed by the date in which it
43 was enacted in the form of (YYYY/MM/DD) and an m-
44 dash (—), and closed with a square bracket (]) resulting
45 in the full format of [## —SB## —YYYY/MM/DD].
- 46 e) Should an article be added to the statutes, it shall be given its
47 own section respective of its numerical position.
- 48 i) The first entry shall be the bill which created the article.
- 49 f) Should an article be removed from the statutes, its section shall
50 be marked as deleted but not deleted from the register.
- 51 i) The last entry shall be the bill which removed the
52 article.
- 53 ii) The removed article shall be moved to the end of the
54 register, irrespective of numerical order.
- 55 ~~(7) —~~ Upon the request of a simple majority of the Senate, the Rules
56 Committee can prepare and provide a report for applicants to the
57 Supreme Court.

62 **Section IV: Enforcement**

63 This Bill shall be presented to the Student Body, the Office of the Vice President of Student
 64 Affairs, and all relevant committees on behalf of the Student Body by the SGA;

66 **Section V: Enactment**

67 This Bill and all its contents shall be the official law of the SGC-MMC upon passage by the
 68 SGC-MMC Senate and approval of the SGC-MMC Student Body President;

69

70 **Section VI: Implementation**

71 Upon the enactment of this council bill, this shall be the official law of the SGC-MMC and shall
 72 make any prior legislation that conflicts with this legislation hereby null and void;

73 Upon the passage and approval of this council bill, the contents of the it shall be made
 74 incorporated into the SGC-MMC Statutes and those provisions of the SGC-MMC Statutes which
 75 contradict this council bill shall be made null and void;

76 Upon enactment of this council bill, it shall be mandated that previous statue amendments
 77 enacted prior to the enactment of this council bill but within this 35th Senate Session be added to
 78 the register.



SB1810 – STATUTE ARCHIVE ACT

PER SGC-MMC STATUTES, ARTICLE IX. AMENDMENTS AND PROCEDURES,
SECTION 9.02 PROCEDURES (b) (ii)

*“Once the legislation has been delivered to the President, they shall have five (5)
business days to sign or veto legislation per Article III of the SGA Constitution.”*
