- C. MOTION: Sen Gaynor: Go into a discussion about The AQUA Act
- D. Sen Gaynor: Read a letter from a student about the aquatic facilities at FIU
- E. Sen Stone: Directed a question to the student body president. Asked about the survey that was sent out.

- F. Sen Marin: As far as numbers go, if they have not gotten in contact to figure out the costs and the funding for new aquatic facilities it doesn't make sense to go through with this if there is not enough research.
- G. Sen Cicconi: This bill is not paying for these services or these activities and this bill gives great options on where these facilities would go and these are only suggestions for the facilities on campus.
- H. MOTION: Sen Stone: Extend conversation by 7 mins: MOTION PASSES
- I. Sen Moya Palacios: This is a resolution, not a bill. We are only recommended that we work with the administration to improve our aquatic pools on campus. Urge that we overturn this veto and we vote on it and we pass an present it to the administration. If there are a majority of students to have more pools on campus than why not.

- K. Sen Stone: We did meet with the director of the WRC and they advised us a lot about this bill.
- L. Sen Gaynor: This has been in the works since July 2022 and I have received a lot of support and I would have never presented this without the appropriate information and SGA is in charge of funding the WRC.
- M. Sen Tunon: We should be more professional and we should not be talking back with attitude or making snarky results. The construction for these advisors would be a concern.
- N. Sen King: Not opposed to getting hot tubs and saunas, but this would require time and construction and the bill needs to be amended .
- O. Sen Rodriguez: Would vote in favor of the resolution as long as the language is changed as well as the clauses.
