11. THE POP ACT HAS BEEN APPROVED

- B. SR 03 009: The MyTextMate Act (vote)
 - 1. Sen Hernandez: Reads the MyTextMate Act. The purpose of MyTextMate is to allow students to be reminded of important class deadlines. This is in collaboration with Canvas.
 - 2. Sen Kukuk: When you get a deadline on canvas you receive it, how would this work?
 - 3. Sen Hernandez: This service is going to be working with the student's canvas but work with their text messages, this is automatic.
 - 4. Sen Algren: How much would it cost to do this?
 - 5. Sen Stone: Is this a service you have to opt into, and can you opt out?
 - 6. Sen Sutton: It's an opt in service. We'd be giving it to the first 1000 students. My guess is that it would be difficult to opt out.
 - 7. Sen Kukuk: Once a test run is done, would students pay this?
 - 8. Sen Sutton: Once we pay for the initial test run, SGA could allocate money to pay for this, either SGA or a fee.
 - 9. Sen Dawson: Is there a plan for when the trial period end to be able to get feedback from the first 1000 students that tried this out?
 - 10. Sen Hernandez: This has not been discussed but this is a good idea in order to get feedback to apply to a larger basis.
 - 11. Sen Reiban: When this legislation was first brought up, I said that it is the student's responsibility to be aware of the deadline so I would say "no" to this.
 - 12. Sen Moya Palacios: I would say "no" to this because if you go on the website and you look at the reviews the maker generates them, and I don't think this would work.
 - 13. Sen Hernandez: This is a test run for 1000 students to see if this works, it's the responsibility of the students to be aware of the deadline but some professors aren't the best at communicating it.

- 14. Sen Algren: FAU, NSU, etc. have used this service or have run a test run. A lot of neighboring universities are using this so we should give it a try.
- 15. Sen Tuñon: In support of it because we are just testing it. A good reminder is helpful especially since students are already so busy with their lives.
- 16. Sen Lares-Chacin: It's only a test run but I don't want students to be spending their money on this.
- 17. Sen Sutton: If we fund this, I will try to be one of the first 1000. It's every student's responsibility but a lot of people would benefit from this.
- 18. Sen Arzola: How are these 1000 people going to be picked? Constantly checking your emails, etc. helps develop your professionalism.
- 19. Sen Hernandez: First come first serve.
- 20. Sen Moya Palacios: Back in the summer when Charlie, the owner of the app, could not respond to some of the questions fellow senators asked and this is the responsibility of the student.
- 21. Sen Loiseau: If this would be implemented it would create positive habits that will lead to better time management.

- A. SB 03 016: The Cell Phone Charging Station Act (vote)
 - 1. Sen Stone: \$1,400 would be allocated to install 2 wall mounted cell phone charging stations at the WRC. The WRC director has approved this collaboration. SGA has agreed to provide this cost.
