  - A. Maria Franzblau: member of YDSA, wants to call for a ceasefire in Gaza.
  - B. Danyel Yurkovitch: Says YSDA and other organizations have been discriminating against certain groups of jews, asks SGA to put an end to it.
  - C. Neha Ahmad: Says this is the first genocide where people praise the oppressor and hate towards the victim. Something needs to change.
  - D. Matthew Gaynor: Says Hamas opened fire on many people. Says this resolution has made Jews and Palestinians feel unwelcome.
  - E. Pedro Rodriguez: Not here
  - F. Zachary Levenson: not here
  - G. Norhan Saber: Supports ceasefire resolution. Says hate crimes have increased and the school has done nothing to make Arabs and Palestinians feel safe.
  - H. Harlan Ridkind: Concern about the effect the resolution will have on campus. Agrees Palestinians have the right to speak, but it is getting over the line. Says atmosphere this resolution brings only accomplishes separation.

#### Public Forum

- Halle says that this is enough, and a ceasefire was called before and it wasn't accepted.
- Kassandra says that the resolution will not affect anything directly enough. Doesnt understand the correlation between the resolution and safety.
- Asks "where do we go when we don't have safe spaces?" Says there is nowhere to go in Palestine. Says renaming the offices is an attack on safety. Says senators should not bypass public forum.
- Says that if the other group can't acknowledge that Israel is a free state and is allowed to be there, nothing will get done
- Brings up the 2 students shot because they were from palestine at a different university. Asking to protect people by agreeing to the cease-fire.



- Pedro, a part of YDSA says that this resolution is a call to end the bloodshed. Says resolution stands by justice.
- Sara says that ceasefire now helps multiple races and beliefs, not just Palestine.
- Says Palestinians s accuse Israelis of genocide, but they just want peace and 2 different states.
- Says senators should not end public comment. Says bills should be read in senate.
- Oscar says he doesn't deny the massacres, so why are people denying all the deaths of children. The ceasefire will not put anyone in danger, just allow for liberation of individuals.

Stone motions to enter a 10min discussion on discharge, PASSED. Stone says: he sent messages to Salup-Cid and he has not responded. Asks him to find common ground and work with him. Salup Sid responds by saying that he hasn't responded because he's been busy. He says he supports CAPS. Arzola says that the senate hasn't been able to gather and speak about the topic. Says this conversation has no place in the chamber. Dawson suggests that the resolution should be voted on in the senate. Sharma praises everyone for their passion. States that this resolution has a lot of large-scale implications that might arise. The Senate is trying to take in all factors while making the final decision about the ceasefire. Hernandez says that this is a tense situation, but this matter belongs to SGA. Its concerned that its been a long time since the ceasefire started.
