Sen. Brochinsky moves to approve the minutes by unanimous consent, with no objections motion passes.

VI. Adoption of the Agenda

- VII. Invited Speakers
 - A. Amanda Manuel
 - 1. Summarized the Stop Haitian Hate resolution, the Haitian Student Union believes the resolution is important and reflects diversity and being a scholar, scholars should pursue truth in all its forms, any questions or clarification requests can be raised
 - 2. 5 min Q&A: Sen. Marrerroo asks about scholar's support, A. Manuel: it is important to pursue the truth being a scholar, no matter for support for specific political figures

Sen. Fineberg: asks about any incidents of harassment or discrimination incidents against Haitians at FIU, A. Manuel: certain sentiments and behaviors on campus are a consequence of the political rhetoric Sen. Jayo-Acuna: would like to know more about the Haitian Student Union goals and advocacy, A. Manuel: the goal is to encourage FIU support for students to be more open-minded, to ensure that what is being said is true and prevent escalation of the matter

Sen. Anish Sharma moves to extend the Q&A by 5 more min, motion passes. Sen. Sharma: asks to further elaborate on Clause 3 and its potential exclusion, A. Manuel: the goal could be accomplished with Clause 3 exclusion, but the specific political announcement led to raise of stigma and rumors on campus



Sen. Mata: asks whether the resolution will benefit the students without Clause 3, A. Manuel: yes, but the resolution benefits not only Haitian but all students, might be more difficult to appeal to students without Clause 3

- XII. New Business
 - A. Discharge of S.R. 5.004: Stop Haitian Hate
 - 1. Sen. Stone read the rules for discharge of legislation
 - 2. Roll call vote on the full reading of the bill: with simple majority the full reading passes
 - 3. Sen. Touissant read the bill
 - 4. Sen. Mata: stated the reason for the SLACK Committee rejection of the legislation due to the language in the legislation clause, no objection against the legislation itself
 - 5. Sen. Stone moves for a debate, motion passes
 - 6. Debate: Sen. Fineberg: considers standing up for marginalized students important, first got the information on the matter from the public speaker but not from the resolution, incidents of harassment need to be addressed in the resolution and the resolution needs to outline the response to rumors and harassment; however, will vote to discharge

Sen. Touissant: made a comment about the purpose of the resolution

Sen. Barriga: some aspects can be incorporated regarding FIU being antibully zone and supporting students

Sen. Lyons: makes a comment on the resolution and support for it, support for the Haitian community

Sen. Jayo-Acuna: politics must be set aside when it comes to harassment, it's the priority of SGA to ensure safety of students and politics is not a concern in the matter, will be voting in favor

Sen. Mata: the legislation can still be helpful without the Clause 3, SGA's duty is to ensure safety and stand against harassment, proposes an amendment regarding unacceptability of harassment and bullying and removal of Clause 3



Sen. Brochinsky: did not know a lot about Haitian culture and community before coming to FIU, makes a comment of the purpose of the legislation and reasons for sponsoring, amendments can be proposed Sen. Salup-Cid moves for a 5-min extension, motion passes. Sen. Salup-Cid: makes a comment regarding Clause 3 and purpose of the legislation to support students Sen. Caseres: is in favor of anti-bullying message, makes a comment about a general SGA position on the matter Sen. Mata: expressed the opinion and concern about Clause 3 and proposed amendments, the matter is national-level; proposed amendments were rejected Sen. St. Rose: considers that FIU as an international school has not made a statement yet being shameful Sen. Brochinsky asks about amendment process, Sen. Stone: amendments can take place after the discharge Motion to extend the debate by 5 min brought up, motion passes. Sen. Salup-Cid: makes a point about the SLACK Committee meeting and disagreement with the approach Sen. Boyo: makes a point about the resolution and Clause 3 Sen. Krause: clauses serve the purpose of providing a background for the matter, including Clause 3, Haitian students want SGA to support the legislation Sen. Fineberg: agrees with the previous statement, legislation is not calling for a specific action but condemns discrimination, should not be obstructed by a clause 7. Sen. Brochinsky moves for a vote to discharge the legislation in a placard vote. 8. The motion to discharge passes in a placard vote 9. Sen. Brochinsky: moves to add the legislation to the agenda for a reading and amendments, motion passes. 10. Sen. Brochinsky read the title of the legislation

- 11. 5 min Q&A: motion to elapse the Q&A by unanimous consent passes with no objections
- 12. Sen. Stone read the proposed amendment to remove Clause 3 and add a statement against bullying and harassment



- 13. Sen. Mata explained the proposed amendment to remove Clause 3, the goal is to strengthen the legislation for the purpose of helping students
- 14. Sen. Mata moves for a discussion on a proposed removal of the Clause 3, motion fails.
- 15. Roll call vote on the removal of Clause 3: the amendment fails
- 16. Sen. Stone introduced the amendment brought by Sen. Barriga against bullying
- 17. Amendments are added; Sen. Stone announces a 3-min recess at 5:40 pm
- 18. Meeting called to order at 5:44 pm
- 19. Roll call vote
- 20. Sen. Brochinsky moves for bypassing the second reading and going into a roll call vote on the legislation, motion passes
- 21. Roll call vote: the legislation passes with 32 yes and 3 no
