- V. Adoption of the Agenda
 - 1. Sen. Gedeon moves to move the reports before the rest of the agenda, motion passes
 - 2. Sen. Touissant moves to have public forum after the reports, motion fails
 - 3. Sen. Touissant asks about the order, Sen. Stone clarifies with the need to have reports before the rest of the agenda
 - 4. Sen. Hernandez asks about the public forum being at the end, Sen. Stone: any Senator can motion to have the public forum at the end of the meeting, no motions follow

 - A. Speaker 1: SGA is for the students, would be for special elections for representation, student pay for attendance so should have a say for representation, student voices matter the most
 - B. Oscar Alvarez: political implication of democracy is transparency and legitimacy, students have an opportunity to chose their representatives, any student input would be better than none
 - C. Sofia Santana: SGA is supposed to represent students, students should choose their representatives
 - D. Brian Levine: new freshmen can get involved, encourages SGA to get new students involved, students should be able to select their representatives; 16 vacancies would not be filled by appointment by the end of Summer; students should speak before the procedures

 - A. Presentation of the Standing Procedures of Senate Vacancies by Speaker of the Senate Alexander Stone / Pro-Temp Alexandra Barriga



- 1. Sen. Stone gave a presentation on filling of the Senate vacancies based on the governing documents: the Senate can elect a representative by a simple majority or call a special election; outlined the process for election through the Senate
- 2. Sen. Barriga gave a presentation on special elections process according to the governing documents; outlined the process
- 3. Sen. Stone: Senators can review the elections code in the Constitution
- 4. Q&A: none

B. Thirty-minute discussion on this

- 1. Sen. Hernandez: concerns brought up during last meeting had to do with timeliness, makes a point about the time needed to appoint 16 Senators
- 2. Sen. Touissant: looked into aspects of appointment, the Senate would take more time to appoint Senators, suggests ways to save the budget on election marketing, students should have a say regarding who represents them; special election would be the most convenient way
- 3. Sen. A. Sharma: Senators need to be pragmatic regarding the matter, choose most practical option in terms of time and finances, voter turnout in the Summer would be low, cannot hold the appointment until Fall since Senators would need training. Interested students can come to the Senate to ask questions for a compromise
- 4. Sen. Gonzalez: voting is a stressful procedure, voting would not be beneficial for students; the cost of election represents an issue as well
- 5. Sen. Salup-Cid: even if turnout is low, the student input would still matter, elections are overall time- and cost-effective, compromise could still be considered for student input
- 6. Sen. St. Rose: makes a point about a timeline and whether it can be shared
- 7. Sen. Brochinsky: committees and exec branch appointments have not been made, candidate interviews by Senate leadership would take time
- 8. Sen. A. Sharma: voter turnout was low in the past for student representation
- 9. Sen. Touissant: there is special allocated budget for elections, no new allocation is needed, tabling could be done for promotion, orientation can be used as well, low turnout would still mater
- 10. Sen. Young: some work being conducted during Summer



- 11. Sen. Hernandez: voter turnout is always a concern, including in national elections, outreach can be done to inform the students, election is a good opportunity for student engagement
- 12. Sen. Sutton: some students are interested in SGA, students who are not on campus in the summer would not have a chance to participate, holding off until Fall is suggested
- 13. Sen. Gonzales: the only benefit of an election would be time, voting system should be improved
- 14. Sen. Mata: an agreement is needed, Summer turnout will be low, holding off until Fall would not be a good option
- 15. Sen. Brochinsky: makes a point about the time requirement for appointment
- 16. Sen. Touissant: in the Fall access to freshmen could be opened up, September is suggested for election, the election takes place over 2 days, BBC campus representatives are asking for a special election for representation
- 17. Sen. Gudipati: a lot of emphasis is on the SGA time, need to consider challenges with campaigning for freshmen; petition for backup could be a solution
- 18. Sen. Barriga: regardless of the decision there will be an advertisement for the students
- 19. Sen. Stone: promotion will be done either way for transparency
- 20. Sen. Gedeon: GPA is needed for running, committees are being created, challenges are present due to unfilled seats, a petition option would be good
- 21. Sen. Stone: established FIU GPA is needed to run for SGA
- 22. Sen. Touissant: some freshmen take Summer classes so will have GPA, committees can be formed once the seats are filled, both options will be impacted by low traffic on campus and GPA
- 23. Sen. Tillias: compromising suggested was a good option, the issue has taken time
- 24. Sen. St. Rose: student voices should be taken into account, agrees with the issue having taken time
- 25. Sen. Hernandez: makes a point about GPA exemption for freshmen, voting system is stressful but students can be empowered
- 26. Sen. Brochinsky: makes a point about unfilled seats
- 27. Sen. Salup-Cid: makes a point about task delegation, special election would be more efficient in terms of time



- 28. Sen. Brochinsky: moves for a vote on the issue through a straw poll, seconded.
- 29. Sen. Salup-Cid: a straw poll is not a binding option
- 30. Advisor Larissa Adames: clarifies the straw poll process
- 31. A straw poll takes place: appointment system 15 votes, special election 11 votes
- 32. Sen. Salup-Cid: moves to continue with the rest of the agenda, motion passes
