- B. Preeminence Resolution: Senate Leadership
 - 1. Sen. Hernandez comments that the resolution was not shared in the email, Sen. Stone: the resolution passed last night, will be shared
 - 2. Sen. Fineberg asked for unanimous consent to read by title only, objections noted. Sen. Fineberg moves to read by title only, motion passes.
 - 3. Sen. Barriga moves to bypass the second reading, motion passes.
 - 4. Sen. Barriga read the bill
 - 5. 5-min discussion: Sen. Hernandez: asks about thanking the Board of Governors despite the actions. Sen. Fineberg: Q&A should precede the discussion, Sen. Stone: agreed, discussion elapsed
 - 6. 5 min Q&A: Sen. Brochinsky: asks about the language of the resolution, Sen. Stone: all Senators can view the document
 - Sen. Toussaint asks about the purpose, Sen. Stone: the purpose is to acknowledge the work required for preeminence
 - Sen. Lyons: asks about the betterment of the University funding, Sen. Stone: explained, SGA does not oversee this funding; Sen. Barriga: explained the purpose of the resolution further to underscore and acknowledge the FIU preeminence

Sen. St. Rose: asks about the purpose of passing the resolution, Sen.

Fineberg: questions must be technical

Sen. Touissant: asks about social media posting, Sen. Stone: to be discussed



Sen. Mata: asked about presenting at Board of Trustees, Sen. Stone: yes Sen. Lyons asked about the scope of presenting the bill, Sen. Stone, Sen. Barriga: explained

7. 5-min discussion: Sen. Brochinsky: suggests not to rush the decision and give it a week, Sen. Stone: the next Board of Trustees meeting this week, advises against that

Sen. St. Rose: comments on understanding the bill

Sen. Mata: FIU is the youngest university to receive the title, it should be acknowledged and brought in the next Board meeting

Sen. Salup-Cid: does not think that saying thank you is wrong, but certain actions on the administration's side would stand against that, no control over the funding

Sen. Fineberg: shares the reservations about sending the bill at the last minute, the resolution thanks the FIU community

Sen. Sutton: the bill was presented late, the Board of Trustees has passed some controversial decisions; there are more pressing matters

Sen. Tillias: moves to extend the discussion by 2 min 30 sec, motion passes.

Sen. Tillias: asks about the next meeting of the Board of Trustees, Sen. Stone:

the SLACK Committee passed the bill on Sunday, the next meeting is on

Sept 12; Sen. Tillias: asks about the next meeting, Sen. Stone: Nov 21

Sen. Barriga: the bill has been in the works, SGA has always supported FIU so it would be important to acknowledge the preeminence

Sen. Hernandez: would vote no, wages have been withheld from female employees, would suggest protecting the academics

Sen. Brochinsky: asks about the second reading, Sen. Stone: was voted against

Sen. Brochinsky moves to table the resolution until the next meeting, motion fails.

Sen. Sharma moves to have a roll call vote, motion passes.

 - 2. Candidate Galindo: gave a speech, presented his background, goals in the position
 - 3. Candidate Derechin: gave a speech, her background, appreciates collaboration and inclusivity, would like to enhance the academic experience, advocate for policies that promote academic excellence, more sustainable practices; advocate to promote mental health and wellness
